


Professor Alison Gopnik of UC Berkeley will astonish and delight us at 6:30 with a talk on "The Scientist in the Crib: What Research Tells Us about Children's Minds". She will astonish with all the ingenious ways she and fellow scientists have found to discover and prove what infants and toddlers are thinking long before they can tell us in language; and *delight* because many of us were convinced by our own children that babies are much smarter, much sooner, than earlier child development authorities admitted. Prof. Gopnik is a lively writer and speaker, a

leading researcher in developmental psychology and philosophy of the mind, and the author of four books and many journal

articles.

What's the connection with our League program? Both LWVBAE and LWVC are emphasizing Education as an issue; a key element is lobbying to expand funding for high quality early childhood education. The research of Gopnik and



others proves that infants and young children are constantly observing, thinking, and learning. We need to nourish and enrich those eager young minds at home and pre-school.

Come early to greet old friends and meet new ones, then enjoy a tasty buffet supper of herb crusted pan-roasted chicken, vegetables, creamy coleslaw and seasonal dessert prepared by our master chef Rainey Sykes and her crew.

After dinner Dr. Gopnik will speak, followed by our business meeting where we will discuss and vote whether to adopt the following Board recommendations:

- Budget for the coming year—not too different from the current year, with no rise in membership dues.
- Readopt our local policy positions.
- Do an update study of local boards and commissions .
- Continue two issues for public education and action: climate change and education.



Erosion of Voter Rights

Leagues of Women Voters have been waiting since the Supreme Court June 2013 decision of Shelby County v. Holder for Congress to restore the requirement that the Justice Department review of certain state and local jurisdictions' changes in their voting laws because of past discriminatory On January 16, 2014, the Voting Rights behavior. Amendment Act of 2014 was introduced in Congress with 22 bipartisan co-sponsors. Currently it is sitting in the House Subcommittee on the Constitution and Civil Justice. It was referred by the House Committee on Judiciary on March 20, Meanwhile, a number of states 2014 (Congress.gov). including Kansas and Arizona continue to enact suppressive voting measures. Statewide Direct Primary Election

Do we want to continue to fund health care in the county by renewing the current half-cent per dollar sales tax? That's the important question asked in County Measure AA. Our Pros and Cons on this measure are posted on our website and will reach members in print soon. LWVBAE and Leagues in Alameda County have voted to support this measure.

Because most state propositions will now appear only on November ballots, only two state measures are on the June 3 ballot. Prop 41, Bonds for Veterans' Housing and Homeless Prevention, proposes taking money from previously unsold veterans housing bonds and using it to create rental housing for homeless and low-income vets. The state and thus the public would also take on the responsibility for repaying the bonds, rather than having them repaid, as in the past, by veterans paying mortgages on houses they had bought.

The second state proposition, Prop 42, Public Records, Open Meetings, would change who pays when local governments obey the Public Records Act and the Brown Act. Local governments would have to pay the costs themselves. Local governments, like state government, would still be required to make public records available to citizens and to notify the public in a timely manner about public meetings and their agendas and so on, but the costs of doing so would no longer be reimbursed by the state government.

You can find these issues explained in brief in the Easy Voter Guide, or more fully in the State Pros & Cons. Both can be found on our website www.lwvbae.org; just click "elections" at the top of the screen to go to the Elections page. The Easy Voter Guide is also available on its own website in Spanish, Chinese, Vietnamese, and Korean, as well as English.

Candidates are on the ballot too. No longer are we voting only for candidates in our own party. Our primaries are now open, so you can vote for any candidate running for an office. The top two vote-getters will face each other in

November. In Alameda County, this may often mean two Democrats.

We will have some competitive non-partisan and partisan races. Eight candidates are running for our Assembly District 15, now that Nancy Skinner is termed out. Five candidates are vying for County Superintendent of Education, as long-time Superintendent Sheila Jordan retires. Two candidates are standing for Auditor-Controller/Clerk-Recorder, as the incumbent Patrick O'Connell leaves office. Leaguers with long memories will be interested to know that Audie Bock, daughter of Felicia Bock, an active League member for many years, is running in the neighboring 10th state senate district..

Ballot Measures and Election of Judges

May 20 Conversation with the League

The Conversation with the League on May 20 will feature a presentation of the pros and cons of ballot measures and a discussion of the pluses and minuses of electing judges.

The first half of the May Conversation will be devoted to a presentation and discussion of the pros and cons of the two state propositions (Props 41 and 42) and the Alameda County Measure AA (see a brief description of the measures in preceding article on this page).

The balance of the meeting will feature a discussion of the pluses and minuses of electing judges, led by Hon. David C. Lee (Ret.), who served the Alameda County courts system for over 30 years and is an expert on judicial ethics. This year, the terms of office for 22 judges expired in Alameda County, but the voters will not find any of these positions listed on their ballots because there are no contests. Only one person filed for the judicial seat and so, under California law, each is considered a "winner" and therefore does not appear on a ballot. The Conversation will explore the ethical issues faced by judges who must be elected, especially when their place on the bench is challenged, forcing an election race. We will also explore alternatives to judicial elections.
