This annual event commemorates the passage of the 19th Amendment to the United States Constitution, which gave women the right to vote, and the founding of the League of Women Voters, both in 1920. Christopher Edley, Jr., Dean of the UC
Berkeley Boalt Hall School of Law, will speak on
The Status of Civil Rights in the USA After the
'Iraqi Freedom' Invasion. Dean Edley recently
came to his position from Harvard Law School.
Following his graduation from Harvard
University in 1978 with a J.D. and a Masters
degree in Public Policy, he joined the Carter

administration as an assistant White House director dealing with, among other things, welfare reform and social security.

He joined President Bill Clinton's transition team in 1992 as a senior advisor on economic policy. He went on to work as associate director for economy and government at the White House Office of Management and Budget, heading a staff of 70 that was responsible for White House oversight of budget, legislation, and departments including Justice, Treasury, Transportation, and HUD. In 1995 he added "Special Counsel to the President" to his responsibilities, directing White House review of affirmative action. Two years later he was made a consultant to the President's Advisory Board on Race Initiative.

PRESIDENT'S COLUMN

This is my valedictory following two terms as President, during which time I have had the pleasure of presiding over a truly excellent Board of Directors. Recognizing that our Berkeley, Albany, and Emeryville League is the oldest and, with 400 members, one of the largest in California, we are often looked to for leadership and asked to become part of projects and take action on civic issues that are both local and beyond our borders.

I want to express my special gratitude to Civics Education Study co-chairs *Jinky Gardner* and *Cathy Lynch*, and their entire committee, for the impressive report they produced that now prepares us for our action phase. Our League's leadership on this issue has caught the imagination of other Leagues in the state that also want to explore how civics education is handled in their local school districts.

Another highlight this year was last August's successful annual Community Luncheon, celebrating the League's 85th anniversary. This year's luncheon committee is planning another celebration of town and gown relations on August 24 at Hs Lordships restaurant. The speaker will be Christopher Edley, the Dean of Boalt Hall Law School. See page 1 for details.

Our major activities this year included:

- The 2005 statewide special election, where we were called upon to provide speakers and distribute Pros and Cons.
- leadership of *Lenora Young* who has coordinated the efforts of the volunteers who patrol the now over 100 locations that carry the voter registration form boxes located throughout our three cities. Unfortunately, Lenora will move to the Portland area this fall our loss, their gain; she will be sorely missed. She has asked me to acknowledge the League volunteers who have distributed registration certificates on a regular basis. They include *Jean Safir*, *Hillary Reinis*, *Wilma Jordan*, *Ruth Maguire*, *Ruthann*

Taylor and Allie Norton. Others who have helped out include Marsha Skinner and Karen Carlson-Olson. We are fortunate that Claudia Berger has agreed to take over Lenora's mission.

- Contrary to our belief that with its incremental progress towards on-line elections some years ago Cal would no longer require our services as volunteer poll observers for the student body election, we were requested to help again this year. The \$4,000 earned certainly helped our budget.
- The State study to update the Energy position has been one of the highlights of this year, particularly a memorable visit to the Lawrence Berkeley Lab for a tour of the energy efficiency facilities.
- "Sunshine Week" was another project in which we have been instrumental---a nationwide project that encourages local efforts to pass "sunshine" ordinances, which allow for open government and access to public records.
- "Clean Money", our ongoing local and statewide effort to promote public financing of elections.
- The Eva Alexis Bansner Fund for Sustainable Communities – there will be two recipients chosen by the committee, chaired by Carol Stone. One, Caryl Hart, has already been selected. Watch for announcements about a special event this fall when the grantee students will make their presentations to the League.

Thanks, everyone, for your countless hours of help and your enthusiastic support of our League program. *Jinky Gardner*, your excellent new President, has my very best wishes for an effective and productive presidency, in collaboration with her outstanding Board and with the support of you, the membership, who make everything happen.

BOARD BRIEFS

The purpose of the special March meeting was to receive the consensus report of the Energy Study Committee prior to its being forwarded to LWVC. The following motions were passed:

- To accept the consensus report of the Energy Study Committee for forwarding to the League of Women Voters of California.
- 2. To commend the Energy Committee for a job well done.

The following motions were passed during the regular April meeting:

- 1. Nominating Committee Report: *Suzanne Chun* presented the Committee's report and a motion was made to accept the report with gratitude.
- 2. Program Committee: Sherry Smith presented the local Planning Program decisions, on behalf of Jo Ann Price, and it was moved to accept the plans as presented
- 3. LWVBAE Position Statement: Following presentation of the LWVBAE Position Statement it was carried by acclamation
- 4. Following an explanation by *Helene Lecar* of Measure A, which is a \$390 million Peralta Colleges bond that will appear on the June ballot, a motion was passed to support Measure A.

Community College Action 2005-06

Let the good times roll!

Once again, the voters of Alameda County have come through for the Peralta Community College District. Although only a 55% Yes vote was required to pass Measure A, the actual numbers were decisive – just under 73,000 for, with fewer than 25,000 against.

The District will now have \$393 million as a reserve to upgrade and modernize the three older campuses and enough to fully furnish the brand-new Berkeley City College building.

With the capital funds to buy modern energy-efficient roofing, insulated windows, heating and cooling systems, lighting, and water-saving plumbing, the district will be able to use the operating funds it now must spend on maintenance and utility bills to provide additional classes and student services.

Construction at our beautiful new campus is almost complete as we go to press; move-in day is now planned for late July, and classes are scheduled to start on August 23.

The ribbon-cutting ceremony will take place at the new campus, 2050 Center St., at 10 AM on Tuesday, August 22, and everyone is invited. While small groups have been led through at various stages of the construction, we will be having a special tour for the League some time in November, once the students are actually in the building and the books are up on the library shelves. Those of us who have been around since this project began to take shape (before the turn of the century!) can scarcely believe how far we have come.

Our 2005-06 year was filled with activity. A grant from the Hewlett Foundation enabled the Berkeley and Oakland Leagues combined to underwrite a public forum on PTV, the Peralta TV station, about the three measures (Props 74, 75 and 76) affecting education on the Special Election Ballot of November 2005. All three

measures, which were opposed by the state League, went down to defeat.

In February, Student Ambassadors from Vista (now Berkeley City College) visited all the 8th graders at M.L. King, Jr., Middle School to talk about how they found themselves as college students, and urging the 8th graders to think seriously about their futures. A follow-up meeting in early March for parents provided an opportunity to discuss ways in which parents could help their youngsters achieve their goals and do well in high school.

In the wings at the state level, Senator Jack Scott has introduced SB 1709, which would not only provide greater funding stability for the colleges but would also require the state Department of Education to notify parents of all 6th, 8th and 10th graders of the many opportunities for pursuing education after high school, and ways to pay for advanced schooling. A slightly different version of the bill, SB 845, is now making its way through the Assembly. The state League has written in support of SB 845, and we'll be following its progress as it wends its way through the legislative process. Stay tuned.

PROGRAM ANNUAL REPORT 2005-06

My warm and heartfelt thanks go to all LWVBAE members who worked to ensure that our League's Program events were effective and successful this year. Willing, dependable, and committed League teamwork was the key to the many accomplishments we're all proud of.

LWVBAE's 2005-06 Program activities kicked off on August 26, 2005 with the highly successful and festive Community Luncheon, chaired by Joyce Jackson. The committee did an outstanding job netting just over \$11,000 for the League's General Fund, while helping the League and community members, including local business people and representatives of UC Berkeley to celebrate the 85th Anniversary of the passage of the 19th Amendment to the U.S. Constitution that gave women the right to vote, and the 85th Birthday of LWV. Two items highlighted the event: a timely speech by Cynthia Gorney, Assistant Dean of the Graduate School of Journalism at UC Berkeley, on the status of the U.S. print media as embodied in the Valery Plame affair; and the bestowing of the first two LWVBAE Distinguished Community Awards to member Eva Bansner, posthumously, and to Berkeley's excellent Youth Radio.

The Fall General Meeting in October at the Northbrae Community Church featured a panel of knowledgeable speakers on the November ballot propositions on which the League took either a pro or con stand. The delicious supper was catered by Fat Apple's.

Co-chaired by *Jinky Gardner* and *Cathy Lynch*, the Civics Education Study continued for a second year. The hard-working and focused committee interviewed superintendents and principals in the three school districts of Berkeley, Albany, and Emeryville and created questionnaires for specific grades in elementary, junior high, and high school. After analyzing the responses and writing a report,

the committee held consensus units in March. The resulting proposed Civics Education position was brought to the Annual Meeting in May and adopted by the members.

In September the State Energy Update
Study got under way with the capable Cochairs Roselyn Rosenfeld and Patricia Kuhi leading a large and dedicated committee. Over
several months the committee made sense of
lengthy and difficult materials to prepare two
sets of consensus units for the members. A highlight of the study was the remarkable
Renewable Energy Tour and Talks for Leaguers
and friends at the Lawrence Berkeley Laboratory in January, arranged by Dr. Arthur
Rosenfeld, renowned expert on renewable energy. The units were held in February and the
results sent to the state League.

The biennial LWVUS program planning unit was held in January, along with that for the Bay Area League. LWVBAE's program planning unit was held in April.

As the last program event of the year, the Annual Meeting was held in May at the Northbrae Community Church. Daniel Purnell, Executive Director of Oakland's Ethics Commission, spoke on the need for Sunshine Laws at the local level and shared his valuable experiences with the Oakland commission. A special supper was catered by Rick and Ann's.

The 2006 Community Luncheon Committee chaired by *Suzanne Chun* began its work in May and is busily accomplishing all the necessary tasks to deliver another wonderful League luncheon on August 24. Thus the circle of LWVBAE's Program year continues. The Board invites, in fact URGES, you to participate in the fun and worthwhile Program activities for the coming year. You'll be so glad you did!

VOTER SERVICES 2005-06 Report

Although last fall was supposed to be an "off year" - it wasn't. The statewide Special Election, Albany's two local measures, and the Emeryville city election kept us busy. We began election season by staffing tables at the Solano Stroll and the How Berkeley Can You Be Festival. We then trained a group of Pros & Cons speakers who addressed groups throughout our three cities. We kept all the usual places stocked with registration forms, and moderated a candidates' forum for Emeryville City Council candidates.

The June 6 Primary election proved easier. With only two state measures and Peralta Measure A, we had no local Pros and Cons to write, and groups to whom we usually speak did not want speakers. We limited our work to stocking the usual places with registration forms, and to delivering the printed LWVC Pros and Cons and the Easy Voter Guides to places where the public can find them.

This fall's General election will be more work. Enjoy your summer, then come back ready to research issues, write and edit, speak to civic groups, deliver registration forms, moderate candidate forums, and be poll workers.

ASUC ELECTION 2006

This year's ASUC election appeared to conclude on Wednesday, May 24, 2006, with an electronic tabulation of ballots in Barrows Hall. For the 28th consecutive year, our League provided oversight services. I say appeared to conclude because, as of this writing, the Judicial Council is considering two student suits that have the potential for voiding the election and mandating a new one. Stay tuned!

As we did last year, the League provided a small number of roving observers to ensure that proper election practices were being followed at the 17 electronic polling stations located around the campus and in student dining commons; and, new this year, in the major campus computer labs where students could vote via the World Wide Web. We also supervised a provisional ballot box for use by students choosing to vote on paper; but, of the 10,873 ballots cast, only 1 was provisional. It seems that students have almost complete faith in electronic voting.

Beginning in March, League supervisors Sherry Smith, Bill Chapman, and Jane Coulter, worked with student Elections Chair Jessica Wren and consultant Leslieann Cachola as advisors on proper election practices. Our advice was required only occasionally, as the Elections Council set up what proved to be a smoothly run election.

For the first time this year, the ASUC Senate allowed voting via the World Wide Web. Two-thirds of the ballots cast came online. The remainder were cast at the traditional campus polling stations. While our expertise does not extend to Internet voting security, we were still able to offer useful advice on proper practices, which are as valid with electronic ballots as they are with paper ones.
