At its July 10 Board Training and Goal Setting meeting, the Board

- discussed "Total Board Responsibility" concept;
- reviewed the LWV Non-Partisanship Policy;
- updated the organization chart and jobs to be filled;

Some perfectly delightful opportunities are coming up this Fall. As the snake oil salesmen of yore used to say: "Are you tired? Are you anxious? Are you frustrated? I have the answer for you, my friends!" Read on.

The LWV has a website called "Smart Voter" that lists all the state, county, and local races in California. Candidates are invited by letter to say what they have to say within a loose framework on this website. The voters are then able to see what the competing candidates have to say — all in one place. Even if they didn't know anything about the candidates before, they can find out now!

I am the local volunteer coordinator for this website (Berkeley, Albany, and Emeryville races) and have found the various facets of this work/play a great antidote for my malaise (derived from disgust over how few people are participating in our democracy and how many are ignorant about how the results happen!).

This year, LWVBAE is going to make a big push to publicize our website and form relationships with candidates and their teams, media, and the potential voters. Registrars of Voters and people who have run before already know and love us! We've been saving them money and putting their message out for years!

So if you are any of the following:

- A person who likes to read one or more local papers and will notify us of newspaper articles relevant to the upcoming races;
- A person who likes to talk to interesting, friendly, new people (the candidates);
- A person who likes to do publicity (taking posters to businesses for display and/or being the liaison with radio and TV stations);

- A person who likes to attend and/or speak at candidate forums or other meetings (we have a 6-minute video on Smart Voter that can be shown at meetings on a VCR and a venue for you to speak); or
- A person who likes using computers, e-mail, and internet and would like to learn more about how to publicize our site via computer.

THERE ARE OPPORTUNITIES varying from 5 minutes to several hours for the election season. Doing SOMETHING will do wonders for your sense of control, anxiety or frustration. And for a lazybones like me, it makes getting up early interesting so that I can see what the recipients of my communications have sent back. We need every one of you who feels a need to DO SOMETHING! Whatever your schedule, you can contribute.

We'll **get together in September** and have a "back room" party to put our act together. And to the three newer members who showed interest several months ago, I'll call you if you don't call me. It's all about good things, folks!

## **New National League President**

League's Grassroots Members Choose *Kay Maxwell* to Head National Organization

The League of Women Voters (LWVUS) concluded its 45th Biennial Convention in June in Miami, Florida, by electing a new national president. *Kay J. Maxwell* of Greenwich, Connecticut was elected unanimously by the state and local delegates gathered at Miami Beach's Fontainebleau Hilton. Elected to serve a two-year term, she will be the national organization's 16th president.

In her acceptance speech, Maxwell thanked members for entrusting her with the leadership of this storied organization. "I am honored and energized to lead the League, which for 82 years has been a voice for citizens and a force for change," Maxwell remarked. "We all know that a democracy isn't something that runs itself. ... It's up to citizens to make it work. And it is up to the League of Women Voters to provide citizens with the information and tools they need to become involved and make a difference."

A League member since 1976, Maxwell ascended to the presidency of the Connecticut League in 1989, and served in this capacity until 1993. She also served as first vice-president on the LWVUS national board in 1998, as the national organization's Budget Committee chair and as a Lobby Corps member on Capitol Hill.

Maxwell, who is a vice president at the International Executive Service Corps, an international economic development non-profit, urged convention delegates to think beyond our own borders and help involve the League in developing democracies.

"I firmly believe that the League should continue to be a player on the international stage. Spreading the message of the League and the positive impact it can have on citizens trying to secure democracy has a tremendous impact on the world. It is in the interest of the League in the U.S. to build strong citizen organizations around the world. We cannot live in isolation," said Maxwell.

In addition to her volunteer work with the League, Maxwell was honored as the first annual Connecticut "Citizen of the Year" award winner in 1993. Maxwell also serves on the boards of the Women's Campaign School at Yale University, the Connecticut Public Affairs Network and Planned Parenthood of Connecticut Public Policy Fund.

### **LWVUS Convention Report**

Held in Miami Beach, Florida, June 14-18

The convention had a total of 634 delegates, including national board members, from 412 Leagues, from all 50 states and the Virgin Islands. The delegate body was much more diverse than the last National convention I had anticipated. While still predominately white older women, there were a number of men, some quite young women and men, and more ethnic diversity than I had seen before.

The major work of the convention was to adopt a program and budget, and to elect officers and other board members for the next 2 years.

### Controversial matters included:

- proposed amendments to the international trade position, arrived at through member concurrence via the National Voter (never done that way before); extensive discussion was followed by a vote to confirm the new position as adopted.
- raising the per-member-payment ("PMP,"
  the dues to LWVUS) by \$2.00 permanently
  and by an additional \$1.35 for 1 year to fund
  the proposed update of the position on the
  election of the US president; the study was
  approved, and so was the increase in PMP.

The current LWVUS position on election of the president, last updated in 1982, calls for direct election, without going through the electoral college, and it was generally felt that there was not adequate member understanding to go forward with action on this position without revisiting the study.

The proposed increase in PMP lead to extensive debate, raising such concerns as the fact that the proposal was announced so late that local Leagues had mostly concluded their annual meetings, so the increase would have to be covered by already tight budgets. Many of those attending the convention were from Leagues on better financial footing; less well-off Leagues were not well represented and were

not able to vote on the proposed increase.

Other proposed studies included reapportionment (redistricting following the completion of the national census), energy, drug policy and proportional representation. Proposals were also made to revive the Equal Rights Amendment.

Prior to the convention, rumors of a challenge to the nominating committee's slate for officers and board members abounded, but they proved baseless, and the slate was approved by acclimation. The program and budget were adopted as proposed, with the addition of the non-recommended item of a study of re-apportionment to be done if adequate funding can be found during 2003-4.

Major problems for the national league are reflections of the problems our local league is facing, regarding membership — not enough active new members to replace the aging membership — which leads to budget problems and problems with how to conduct League studies using study committees and the consensus process. How to do all the things the League says it wants to do with very limited funds. Loss of income and principal due to changes in the stock market were cited as the reason for much of the problem, causing foundations to cut back on funding new projects and to decrease the amount they are giving to continuing projects.

Because of the fear of a challenge to the nominated slate of officers and board, said slate was very visible at this convention, and the opportunity to ask questions and get to know them was much greater than at previous conventions. It also helped to have the chairman of the nominating committee be Jean Matusuura, former president of the Bay Area League, and Rosie Stephens, who was on the California state board,, as members of the committee, in addition to members of the slate being from California: Xandra Kayden and Jan Hirohama, both from Southern CA Leagues.

- Vote **No** on the statewide Racial Privacy Initiative.
- Vote No on the statewide After School Education and Safety Program Act.
- Vote No on the statewide Traffic Congestion Relief and Safe School Bus Act.

- Write a letter to the editor of one or several local newspapers explaining the League position and urging voters to support our position.

   Pair up with another League speaker to present our views -- or the Pros and Cons -- to community groups through the Speakers Bureau, and enjoy the lively discussions that follow.

## IT'S OFFICIAL! THE NEW VISTA COLLEGE IS ABOUT TO RISE

Groundbreaking ceremonies for the construction of the new Vista Community College campus will be held on October 23, 2002, so SAVE THE DATE. Plans for celebrating and the kickoff for the new Friends of Vista College foundation are still jelling as we go to press. More details will be available at our Fall Meeting, September 19.

But don't hold your breath. Completion is expected in 2004 and full occupancy is slated for Fall, 2006. In the meantime, keep an eye on Proposition 47, the education construction bond measure on the November 2002 ballot. Our local Measure E bond, passed by Peralta voters in November, 2000, will pay for the building itself, but if, and only if, voters statewide approve Proposition 47 this November is Vista expected to receive the \$28.5 million needed from the state to equip the new building.

After they are registered, we will be active in informing the students, distributing our Pros and Cons which we hope they will study and discuss in their classes and take home to discuss with their parents.

As well, we ask your help in registering younger students for the Mock Election, a nationwide effort, to be held on November 1. 2002 threatens to be another bad wildfire year and communities which border on wildlands, like Berkeley, will again be at risk. The Environmental Concerns Committee will start its fall program with a meeting dedicated to learning about wildfire risks, what is being done to reduce them, and what property owners can do to improve chances to make it past the fire next time.

Our September speaker will be Kenneth Blonski, Fire Mitigation Advisor of the UC Forest Products Laboratory. Ken has had a distinguished fire management career with the United States Forest Service and was principal organizer of last year's conference commemorating the tenth anniversary of the 1991 fire. He is co-chair of the Diablo Fire Safe Council, an organization of stakeholders in wildfire control in Alameda and Contra Costa counties. He is now organizing a conference for September 21, 2002, aimed at empowering neighborhood organizations concerned about fire safety.

## League Joins Coalitions on Two Ballot Measures

After an extensive study, the LWVBAE updated and adopted very clear positions on housing in 2000, thereby affirming its commitment to work toward expanding our communities' housing stock to provide for the needs of low-and-moderate income households.

Two measures on the 2002 Berkeley ballot clearly called for our action under these positions. One is the "Berkeley Height Initiative," which runs counter to our adopted positions, and which, therefore, the League is opposing. The other measure, which the League is supporting, is an increase in the real property transfer tax, which would help relieve the serious need for safe and affordable housing, and which we are therefore supporting.

The League has joined citywide coalitions working on both of these measures. See the October VOTER for more details on these and other ballot measures.
