# GET INVOLVED !!!

This election, as with every election, the League of Women Voters remains non-partisan. That is, the League never supports or opposes a political party or a candidate. The League has two areas of activity at election time: Voter Service and Action. Voter Service is educational and objective in content and aimed at making voters knowledgeable about the issues and the candidates, as well as registering voters and getting them out on election day. League Action involves a stand for support of or opposition to issues on which the League already has a position that was arrived at after a period of in-depth study and discussion. League Action is not undertaken lightly, and only after Board discussion and a vote. On the other hand, just because the League has a position on which to base a stand on a given ballot measure is not reason enough to take a stand. This is basic background for understanding how the League has come to take a stand on some of the measures on this November's ballot.

• Reviewed our Nonpartisan Policy and accepted the resignation of Ruth Ganong as Local Action Chair for Albany until after the November election;

- Reviewed our Policy on Diversity and guidelines on joining a coalition and meetings with other organizations;
- Voted to recommend the consensus on Vista Community College study for adoption;
- Discussed LWVBAE community services and voter service plans for this fall;
- Ratified the Executive Committee's decision to sign the Berkeley Public Library Bond Measure on the November ballot;
- Endorsed the Gann re-authorization measures on the Berkeley ballot (Library, Parks, Emergency Medical Services);
- Voted NOT to sign ballot arguments on the two Berkeley School measures;
- Heard reports on the 2<sup>nd</sup> Annual Community Luncheon, Fall General Meeting, and other ongoing activities.

## **Mock Election 2000**

# National Student/Parent Mock Election To Be Held on Thursday, November 2, 2000

LWVBAE will be cooperating with the Berkeley, Albany, and Emeryville Unified School Districts and the PTAs to offer Mock Election 2000 to the high schools in the three cities, as well as to a few selected lower grade schools in Berkeley. *Helene Lecar*, Education Director, is working on the Berkeley effort, *Karen Carlson-Olson* is dealing with Albany, and *Helene* is recruiting an Emeryville member to handle that city's high school.

Mock Election is a tool to teach students about the process of voting, of involvement, and of democracy at work It's especially important because it gives students and their parents a sense of the power of participation. This is a free project that does not require that parents be citizens or registered to vote in order for their children to participate. It's nonpartisan and nonprofit. The National Student/Parent Mock Elections is administered by the University of Arizona, School of Public Administration and Policy.

The three basic elements of this program allow it to be as simple or elaborate as each teacher and his/her pupils want it to be. It involves:

- School registration
- Classroom or school discussion/activities
- Voting on Mock Election Day.

LWCEF has selected three state ballot measures for teacher focus and student voting. These are Prop. 36: Drug Treatment Diversion Program; Prop. 38: School Vouchers; and Prop. 39: School Facilities 55% Local Vote. Locally, only Berkeley has any school-related measures: AA, a bond measure for school capital repairs and rebuilding, and BB, a parcel tax measure for school repair and maintenance. Of course, the students will also be voting for local, state, and national candidates.

We will be using the state League's *Easy Reader Voting Guide*, a pro & con publication, and our *Local Pros & Cons* as learning tools in all the classrooms. The League of Women Voters of California Education Fund (LWVEF) is serving as the California State Coordinator for Mock Election 2000 in California. Secretary of State Bill Jones is the Honorary Chair. Mock Election Day will occur on Thursday, November 2, 2000, and CNN will broadcast the nationwide candidate results that evening. We are negotiating with local media to do the same for the local issues.

## **Smart Voter Update**

Many of you know that Smart Voter offers voters a unique ballot lookup and election material on local to statewide candidates and ballot issues. But did you know that Smart Voter also leads to many other election sites? Smart Voter offers *Pros & Cons* on the state ballot measures in English and Spanish; the *Easy Reader Voter Guide* in four languages; questions and answers on voting information; and links to a host of other sites. Explore these and more at <u>www.smartvoter.org</u>, the voter's one-stop election site.

The University of Southern California Annenberg School for Communication invited Smart Voter to staff a booth on Democracy Row at the Democratic National Convention. Smart Voter volunteers distributed thousands of bookmarks and pins and demonstrated Smart Voter on a large screen TV. It was great publicity for Smart Voter and the League.

Smart Voter is a charter member of another highly visible election site: Web, White & Blue, a nonpartisan site sponsored by the Markel Foundation. In 1998, WWB sent more visitors to Smart Voter than any other website. It is found at <u>www.webwhiteblue.org</u>. (Excerpted from LWVC material.)

#### LWVBAE November 2000 Election Activities Need Your Help!

Our League is working on a number of activities for the November 2000 election in Berkeley, Albany, and Emeryville and we need the help of all the members we can get! Please call the office or Phoebe Watts, Voter Service Chair (525-6614, or e-mail **phoebewatts@cs.com**)<sub>2</sub> to learn the specifics and volunteer for one opportunity or more to help make democracy work. Following is a brief description of those activities.

#### **Election Activities**

• <u>Voter Registration</u>: We'll be registering voters through the **Oct. 10 deadline** at: neighborhood and city Fall events; supermarkets on weekends; Sproul Plaza; UC Residence Halls, Sororities/ Fraternities; Berkeley Flea Market on Saturdays; downtown BART Plaza on Thursdays, 11 am to 2 pm. League supplies the libraries, post offices, banks, and other institutional locations with boxes of voter registration forms. Call the office with suggestions for locations to put the forms or to pick up forms for your use.

• <u>Pros & Cons Publications</u>: To help voters **understand the measures** on the November ballot and the consequences of a yes or no vote, the League researches and writes a balanced presentation of each measure on the ballot, with both pro and con arguments. The state League puts out the publication on the state ballot measures and our local League writes the information for the city and county measures. Both are in newspaper format and LWVBAE distributes them widely throughout our cities. Call the office to reserve and pick up packages of 10 or more.

• <u>Mock Elections and Easy Readers</u>: With the co-sponsorship of local PTAs, the League will be holding Mock Elections at the **high schools in our 3 cities**, as well as at selected other schools.

In connection with these events we supply *Easy Reader Guides*, a simplified version of the *Pros & Cons* that also include a photo and abbreviated information on each candidate.

• <u>Candidates Meetings</u>: We are sponsoring candidates meetings for the State 9<sup>th</sup> Senate District and 14<sup>th</sup> Assembly District; Peralta Community College District Trustee Area 4; Berkeley City Council Districts 2,3,5,6; BUSD and AUSD Boards of Education; and Berkeley Rent Board.

All of these will be co-sponsored by the Berkeley *Daily Planet*. Four of these candidates meetings will take place **live** on BTV, Channel 25, with the co-sponsorship of Berkeley Community Media, on four Thursday evenings in October: Districts 2 and 5 together; Districts 3 and 6 together; BUSD School Board candidates another evening; and finally the Rent Board candidates. These live shows will be taped for airing several more times before the election. (Please see the **LWVBAE Oct.-Nov. 2000 Election Calendar of Events** on Page 8 of this issue.) Call the office and check the Berkeley *Daily Planet* as more events will likely be added.

• <u>Issues Forums</u>: LWVBAE has a **Speakers Bureau** of trained Leaguers who make objective proand-con presentations of all the ballot measures for the Nov. 7, 2000, election to any community group that makes a request in time for the League to make the appropriate arrangements. Call the office to schedule a presentation for your group or to check on the dates and locations available for you to attend. #### In Memoriam

Dorothy Field, a nationally and internationally respected gerontologist and long-time League member, died September 28 in Berkeley. She was 74. She was Director of the Berkeley Older Generation Study, at the University of California, Berkeley. She was widely known for her studies of older people and the attributes they held in earlier life that contributed to a serene old age. She received her Ph.D in developmental psychology at the University of London in 1975. Field was also an Adjunct Professor at Penn State University and the University of Georgia, as well as a Fulbright Scholar at the University of Bonn, Germany, before returning to Berkeley. She is survived by her companion of 18 years, Ivan King, and her four children, Graham Moody III of Loleta; Stuart Moody of San Rafael; Kate Moody of Kula, Hawaii; and Carlin Mills of Bloomington, Indiana.

*Dorothy* was active politically in school issues in the late '50s and early '60s. She worked on school tax and bond issues and helped to elect Berkeley School Board members including Carol Sibley, Judge Spurgeon Avakian, Reverend Roy Nichols and U.C. Professor Sherman Maisel. The most pressing problem of that time was the de facto segregation that existed that led to different curricula in the three junior high schools. *Dorothy* attended Smith College and was one of a group of alumnae of the "Seven Sisters" eastern women's colleges who interviewed and recruited women students in this area.

Measure AA	Measure AA would authorize The Berkeley Unified School District to issue \$116,500,000 in bonds to repair, upgrade and add new classrooms to address overcrowding and facilitate reduced class sizes, increase seismic and fire safety, replace deteriorating floors, windows, restrooms and roofs, upgrade school kitchens, and modernize science labs. Measure A funded only the most urgent seismic upgrades, and increased student population is putting stress on facilities. A 2/3 vote is necessary.	SUPPORT

Measure P	Measure P would authorize the City to issue up to \$5,200,000 in bonds to renovate, expand and upgrade Branch Libraries. This authority is needed to qualify for state library improvement funds, and the bonds would be issued only if matching funds from the State or some other source provide at least 65% of the cost of the improvements. Measure S included no funds for the Branch Libraries and upgrades are needed. A 2/3 vote is needed.			
Measure V	Measure V would re-authorize the City, over a four-year period, to spend the Library Tax approved by voters in 1988. Required by state law, this re-authorization entails no new taxes. The moneys are needed to continue the many valued programs and services that were restored after the drastic cuts caused by Proposition 13. A majority vote is needed.			
Measure W	Measure W would re-authorize the City, over the next four years, to spend the proceeds of the Parks Maintenance Tax as approved by voters in 1997. As with Measure V, this is required by state law and entails no increase in taxes. A majority vote is needed.			
Measure X	Measure X would re-authorize the City, over the next four years, to spend proceeds of the Emergency Medical Services Tax, as approved by voters in 1997. As with the above two measures, this is to comply with state law and entails no tax increase. A majority vote is required.			
Measure Y	Measure Y would amend the rent ordinance to restrict a landlord's ability to evict for landlord/relative occupancy. We oppose the seriously flawed process by which the City Council placed this measure on the ballot and believe it is biased against small property owners. A majority vote is required.
