EXCERPTS FROM LWV BAY AREA VOTER - AUGUST, 2004

The Continuing Saga of the Transbay Terminal

The primary party appealing the certification of the EIR for the new Transbay Terminal is the owner of a parcel at 80 Natoma [San Francisco] that was identified in the EIR for acquisition because it is in the path of the underground tracks for the CalTrain extension and future High Speed Rail. The owner, Myers Development Co., had not even commented on the draft EIR. The final was certified in April. Early in May, they began construction on the site claiming they had entitlements for a 51-story condo tower. Those entitlements were challenged and in June the San Francisco Building Dept. issued a "Stop Work" order to review the entitlements.

Engineers worked on proposals that could accommodate both the tower and the train. A concrete box could be built that would allow construction above it but the box would have had to be built first and it would be a couple of years before it could be completed. But Myers insisted no delay would be tolerated. The only way to possibly accommodate the continuation of construction would be to decrease the radius of the track and build a complex costly retaining wall. This would have shortened the station¹s track meaning only short trains could be accommodated or people in the last cars would have to drag their luggage through other cars to detrain. Since Transbay Joint Powers Board¹s responsibility to the public is to deliver the most efficient and cost effective project, they have little choice but to acquire the property. Their offer of \$32.2 million has been rejected by the developer. The next step to move this project forward will be to start the process of eminent domain.

Proposed Land-Use Guidelines for Transit Station Areas

The Metropolitan Transportation Commission is considering a new policy that would condition the release of discretionary transit funds on the adoption by local municipalities of transit-supportive zoning guidelines. The guidelines would only apply to projects in the Regional Transit Expansion Policy (RTEP), also known as Resolution 3434. The RTEP will be expanded to include projects in Regional Measure 2, such as ferry terminals.

The Transportation and Land Use Coalition (TALC) is proposing specific land-use guidelines to MTC that would apply to transit station areas, and the LWVBA, as a member of TALC, has been asked to endorse these guidelines.

Proposed Goals

Land Uses and Residential Densities Around Transit Stations and Stops

- 1. Improved accessibility to transit and increased transit ridership, by providing for higher density/ higher intensity, walkable communities near transit stations and stops.
- 2. Encourage a mix of transit-supportive residential, commercial, and employment opportunities, to make transit-oriented development attractive to a wider market.

Infill Housing and Housing Affordability

- 1. Efficiently use the land within walking distance of a transit station to provide housing, meet regional housing needs, and better encourage transit ridership.
- 2. Provide housing that meets the needs of people at all incomes and that includes both rental and sale units.

Retail and Office

- 1. Provide for neighborhood-serving retail that is primarily supported by households and office workers within the Transit Zones
- 2. Encourage uses with greater employment density and design that encourages transit ridership.
- 3. Prevent incompatible uses, such as big box and other regional retail that generates mostly vehicular traffic and discourages transit use.

Parking

- 1. Minimize the amount of land dedicated to parking, while still providing sufficient access to stations.
- 2. Encourage station access by walking, biking and transit.

Pedestrian and Bike Friendly Environment

 Encourage transit ridership, bicycle and pedestrian activity, and access for people with disabilities by providing high levels of access, safety, and continuity for pedestrians and bicyclists in the transit area.

LWVBA supports these goals for development around transit stations, but we have not studied, nor are we as an organization informed sufficiently, to sign on to the very specific zoning criteria recommended by TALC. LWVBA Board decided that we will issue our own separate statement in support of the goals, but will decline to endorse the specific TALC policy recommendations.

EXCERPTS FROM LWV BAY AREA VOTER - SEPTEMBER, 2004

PRESIDENT'S MESSAGE – SEPTEMBER, 2004

The League of Women Voters of the Bay Area believes that government at the regional level should be structured so that it can effectively and responsibly solve those problems that transcend political boundaries. Our longestablished position favors the creation of a multi-purpose planning agency for the Bay Area, or in the interim, consolidation of existing regional agencies. Yet those goals are not on the horizon; in fact, the prospect of these occurring seems to be moving farther and farther away.

In the meantime, we're trying to advance the "regional viewpoint" for both local land use decision-making and issues that transcend local boundaries, such as transportation system planning, air quality, quality of the bay, etc. Current projects we're monitoring include the connection between land use and transportation planning which is moving forward in MTC's development of its Transportation 2030 Plan, and taking a new look at the status of regional planning in the Bay Area with the formation of the ABAG-MTC Joint Policy Committee. We'll keep you posted on these in the coming months.

LWVBA ACTION HIGHLIGHTS Ballot Measures

On the November 2004 ballot, the LWV Bay Area supports, and has signed ballot arguments in favor of, Measure BB, AC Transit Parcel Tax increase and extension, and Measure CC, East Bay Regional Park District Parcel Tax in Area 1 (primarily along the west side of the District). As of this writing, we have not yet taken a position on the BART general obligation bond measure for seismic retrofitting, but will let every League in the District know if we decide to do so at a later date.

With the consent of LWV California, LWVBA also wrote a letter to the California High Speed Rail Authority requesting that all alternatives for the HSR project in Northern California should be analyzed in the EIR, including the Altamont Pass route.

Saving Regional Measure 2 – Bay Bridge Cost Overrun -

Ten days before the end of the Legislative Session, Gov. Schwarzenegger proposed legislation to require the Bay Area, instead of the State of California, to pay for the entire remaining cost of the SF Bay Bridge reconstruction, which is substantially over budget.

Part of his solution was to ask the Bay Area voters on this November ballot to approve the use of the Regional Measure 2 increase of \$1 in bridge tolls, just approved in March 2004, for the Bay Bridge instead of for the projects that were ident-ified in the measure. LWVBA, which signed the argument in favor of RM2, along with the Trans-portation and Land Use Coalition, launched an effort to protect RM2 projects, and to protect the Bay Area transportation ballot measures on the November ballot in 5 counties and BART from a competing transportation funding measure.

We went to Sacramento for a day of lobbying on Monday, August 23, and LWVBA's letter to the editor was printed in both the *SF Chronicle* and *San Jose Mercury News*. As of the close of the session, a bill to arrange enough money to award the bid on the east-span tower, pending an audit of the cost overruns, passed the Senate but did not get through the Assembly before adjournment. The Governor's proposal did not get out of an Assembly Committee, so there will be no measure on the Nov. ballot, and RM 2 is saved for now. There is still no solution about how to pay for the remainder of the Bay Bridge project. Stay tuned.

In response to concerns by local leagues and others, the LWVC Board voted at its July meeting on a motion to revise the schedule for the energy study. Local Leagues will not be expected to conduct the consensus process in the fall of 2004.

Rather, local leagues will conduct the consensus process in fall or spring of 2005. The exact timing will be published in a future UPDATE. This extension of time will allow the energy group to fully develop the energy study kit and will allow local leagues more time to prepare for the consensus process.
