## STATE EDUCATION UPDATE

At the May 2003 League of Women Voters of California State Convention in Oakland, the delegates overwhelmingly adopted an update to our present Education Position, last updated in 1983. They were inspired to do so by testimony from the then State Board Director for Legislation, our own *Anne Henderson*. *Anne* testified that LWVC has often been prevented from taking action in recent years by an Education Position which is outdated because the situations that the position addresses have changed so much and new issues have arisen.

A State Study Committee was formed, with *Doris Fine*, an LWBAE member on the Committee. *Doris* will be working with the LWVBAE local study committee to present the State Study Committee findings to you. Join us to determine how the League of Women Voters of California should address educational issues over the next several decades.

School reform is a hot topic in Sacramento: from the Governor to the Joint Legislative Committee to Develop a Master Plan for California Education; to the Legislative Analyst's Office; to the Public Policy Institute of California. At the unit meetings, the local study committee will present recommendations from these entities and you will have a chance to discuss them and decide which, if any, the League should support.

We may decide that the wording of our current Education Position is still appropriate and merely needs to be expanded to include the new concerns of the 21<sup>st</sup> century.

## PRESIDENT'S COLUMN

League members, both new and experienced, have a chance—coming up quite quickly—to get acquainted on a kind of crash-course basis with the “League Consensus” procedure.

Elsewhere in this issue of the VOTER, you will find information on the LWV California State Study on “What is the Condition of Public Education in California Today?” The last such state study was in 1985 and of course much has changed since. So LWV California is updating that nearly-20-year-old study, and our local Leagues are the keystone in the process.

In December and January, our League will hold “Unit Meetings” of two hours each, held in both the daytime and evenings, to present information from the LWVBAE study committee. At those Unit meetings, members attending will be asked to reach a “consensus” of opinion that will be forwarded to our LWVBAE Board for its consideration and subsequent forwarding, by mid-January, to the LWV California Board.

The December Unit meetings will concentrate on financing of public pre-kindergarten to grade 12 education; the

January meetings will discuss governance and accountability and assessment.

I urge all members—especially newer members who have not had a chance to participate in a state or local study and experience the excitement of consensus-development—to select one meeting in December and one in January, and be a part of one of the main reasons for the existence of the League: education of our membership and the greater public on important civic issues, on the way to developing League positions that lead to League action.

We can make a difference, and here's how it begins. I look forward to seeing many of you at a Unit meeting this winter.

## LEAGUE URGES VOTERS TO VOTE WITH THE LEAGUE

During the weeks leading up to the election, League members spent many hours handing out "Vote with the League" information to the public. These were our recommendations for voting on State, regional and local ballot measures, based on League "action positions."

Members who participated were deeply gratified by the thanks we got from people who accepted our handouts. Many took the time to stop and tell us how much they appreciated all the work the League does for the public. Some said they had "pretty much made up" their minds how they will vote, but were glad to get the League's thoughts, "which I'm sure I'll agree with." We distributed several thousand copies at sites that included supermarkets, BART stations, the UC campus and busy commercial areas.

## ELECTION NIGHT AT THE COUNTY REGISTRAR OF VOTERS' OFFICE

Before the election, the Alameda County Assistant Registrar of Voters, *Elaine Ginnold*, recruited two League members and two Grand Jury members to serve on a "Logic and Accuracy Observer Board" for the November 2 election. *Sukey Wilder* of Oakland and *Jean Safir* of BAE were the two League members who shared the honor.

Our job included watching the voting records being brought in from all the local precincts in the county after 8 p.m. and then seeing what the Registrar's staff does with these records. The more important part—and the hardest part—was to understand how the process leads to a valid cumulative record of all the votes cast in the county. Brad Clark, the Registrar, and his staff—especially *Elaine*—were enormously helpful in answering all our questions as we kept trying to meet that challenge.

Counting the large number of absentee ballots—double the number ever received before—was begun the week before the election. The first step was checking the signatures on the outside of the envelopes against the signatures previously stored in computers.

### League Speak

- Action:** Steps taken to influence public policy consistent with League positions.
- Consensus:** Agreement reached after a sustained study and group discussion at Unit meetings of a substantial number of members, who are considered representative of the whole. It is not just a simple majority, nor necessarily unanimity.
- Position:** The League consensus on a public policy issue which provides the basis for action. Positions exist at each level of League. Individual members are not required to agree with all League positions or action.
- Stand:** Decision made by a League board at the appropriate level to take action based on the appropriate League position.
- Study:** Topics for research decided by delegates to national, state, and Bay Area conventions and by local Leagues at their Annual or a properly-noticed General meeting.
- Unit Meeting:** (Units) It is at Unit meetings that consensus is formed for the purpose of updating positions or forming new positions. Units are led by a discussion leader and allow for member participation and feedback of opinions and ideas.
- Update:** A study of limited scope, to re-evaluate an existing position in light of new information, changed circumstances, and/or conflict with another position, with a view to considering a position change.

The ballots were passed through optical scanners that did a cumulative count of the votes. Since this is heavily labor-intensive work, it was only partly completed before November 2.

The electronic voting machines used at the precincts recorded votes on both paper tapes and data cards, and the latter were used to enter the data into computers at the registrar's office. This gave the initial count, which was transmitted to Sacramento continuously throughout the evening and was completed in the early morning hours.

Beginning on Wednesday, work resumed to finish processing absentee ballots that arrived before the election, as well as those that were dropped off at local precincts. The provisional ballots that were returned from local precincts were also processed during the rest of November. Since the total number of absentee and provisional ballots made up about 25 percent of the ballots cast in our county, the final counts weren't available for several weeks.

The bottom line is that both *Sukey* and I were greatly impressed with the professional way the Registrar's staff does it's work, and still they made time to answer questions from observers such as us two. Although I don't understand what goes on inside "the black box," I can attest to the care and dedication of those handling the flow of paper and electronic data.

**RECORD NUMBER OF VOTER  
REGISTRATION FORMS DISTRIBUTED**

LWVBAE distributed voter registration forms to 118 different sites in Berkeley, Albany and Emeryville so far this year. This contribution to voter service was accomplished by the consistent hard work of many league volunteers, including *Jean Safir, Wilma Jordan, Allie Norton, Hillary Reinis, Ruth Maguire, Jill Martinucci, Jinky Gardner, Ruthann Taylor, Sherry Keith, Helene Lecar, Marsha Skinner, Jeanne Klems, Carol Talbeck, Karen Carlson-Olson, Stephani Antalocy* and *Jody Bush*

In addition to the usual sites such as government offices, libraries, senior centers and fairs and parades in Berkeley and Albany, members distributed forms to many sites not previously serviced by the League such as restaurants, coffee shops, theaters, banks, the major markets, senior residential homes, record stores, book stores and other sites on Telegraph Avenue and Shattuck Avenue. Distribution of voter registration forms brought to the attention of local businesses an important function of League voter service activity.

Not counted in the number of sites was the League office itself, where office volunteers distributed registration forms to individuals and organizations who obtained them from us because they knew of our activity in this area. At least 1,000 registration forms in Spanish and in Chinese were picked up from the office as well.

Voter registration is an ongoing activity and forms mailed in now will register voters for the March 2005 election.

Lastly, Renata Tubman represented the League at a resources fair put on at the Mabel Howard Apartments and got residents there registered. Thank you all!

Another important piece of work began on August 8 when the ballot closed and the LWVBAE jumped on the phone to the city clerks to get all the information on the various ballot measures. The League wishes to extend our thanks to Sherry Kelly, Jackie Bucholz and Karen Hemphill, the City Clerks of Berkeley, Albany and Emeryville respectively, and their staff for all their help and support in getting complete information to us very quickly. Armed with the data our writers, Jean Safir, Helene Lecar, Fran Packard, Phoebe Watts, Ginette Polak, Suzanne Chun, Pat Kuhi, Eloise Bodine, Ruthann Taylor, Ruth Ganong, and Jinky Gardner, dove in and started writing the local Pros & Cons. Fran deserves special notice because she wrote up four measures herself and provided the chart which compared all the money measures on the Berkeley ballot. Anne Henderson also contributed the helpful paragraphs explaining why the cities are having the budget crunches that they are having.

After writing and critiquing the text for the Pros & Cons, they were passed to our editors Luanne Rogers and Jody Bush who caught a bunch of errors and set us straight. Next on to our wonderful formatter, Marylyn Coons, to get the material production-ready, and one last editing run past Irene Hegarty. At last the Pros & Cons went off to the printer, and an electronic version went to Bill Chapman who got them on our website pronto. Thank you, all!

While we were waiting for our local Pros & Cons to come back from the printers, the State Pros & Cons arrived, all 5,000 of them with an incorrect title printed for Prop 67. No breathing time! Over the next several days many of you came to the office to help.

## MOCK ELECTION AT ALBANY HIGH SCHOOL TWO PERSPECTIVES

Albany High School has a responsive and responsible student body, as demonstrated during the 2004 Mock Election on October 28. Even with all the wonderful distractions of Homecoming Week, students took the time to register, resulting in 735 students eligible to vote or 64 percent of 1153 total enrollment. On Election Day they voted before school, during breaks and class (if their teacher excused them or brought them as an entire class), and after school, since the poll was open 7a.m. – 4 p.m. A very respectable number of 550 students voted, 48 percent of enrollment or 75 percent of those registered. Albany's Alternative High School, MacGregor High School, also participated with 20 students.

Selected classes were able to attend an Albany School Board Forum, during 5<sup>th</sup> period on October 20, to ask questions of the candidates.

Printed Voter Guides and state and local ballot measure Pros & Cons were provided free to all students by LWVBAE, which also organized the School Board Candidates' Forum. The Albany High School PTA funded all copying costs of registration forms, signs, sample and official ballots.

More than 30 parents, community, League members, and student volunteers helped with registration and on voting day. Support from Cougar, Leadership, Math, site administration, Social Studies and Special Ed staff helped make the event successful. The Albany High School Mock Election was featured in the West County Times on Sunday, October 31. (See next column.)

I'd like to thank League members *Jinky Gardner* (who ordered printed material), *Phoebe Watts* (who arranged the candidates' forum and sorted questions), *Sherry Smith* (who moderated at the forum), and *Karen Larson, Virginia McKone, and Sheryl Black* (who helped with the election itself).

### THE STUDENTS ARE JUST PRACTICING FOR THE REAL THING, WHICH SOME SAY IS THE ONLY WAY TO CHANGE THE LAW

#### Mock vote no joke for Albany High

ALBANY - The elections are over as far as Albany High School is concerned. John Kerry clinched the presidency, winning 87 percent of the vote. Stem cell research is a go. More casinos in California? A-OK. Senior Wendy Gu, 17, cast her ballot last week after school. "It's the only way we can really change the law," Gu said. She's just practicing, of course. Nearly half of Albany High voted Thursday as part of National Mock Election Day, which drew in 2.8 million students across the country. President Bush beat Kerry 50 percent to 43 percent in national student elections.

Across the state, 90,500 students participated, according to the California Secretary of State's Office. The goal is to get students comfortable with ballots before their real turn comes at age 18, said *Karen Carlson-Olson*, an Albany parent and a mock election organizer from the League of Women Voters. "There are so many young people who look at ballots and say, 'Oh, my God, I can't read all this,'" *Carlson-Olson* said. "It's to demystify voting and imprint upon them the importance of voting."

Freshman Amanda Stevens, 14, turned in her ballot and promptly slapped an "I voted" sticker on her right cheek. League volunteers handed her a yellow pledge card she can use to make a voting-age friend or relative promise to vote. Amanda didn't register in advance. But when league volunteers asked her to cast a ballot, she obliged. "It seemed like fun," Stevens said. "And it only happens once every four years."
