

The national League is updating its study on agriculture and you can be a part.

Our League has joined with the Leagues of Oakland and Piedmont to study the issue and form a consensus. The joint group plans to alternate daytime and evening meetings.

The national League has not yet announced the precise policy consensus questions that local leagues will be asked to decide. However, in general, the agricultural study will cover a wide range of issues, basically in two groups: technology and finance.

<u>Current Technology</u> issues in agriculture including genetically modified organisms (GMOs), herbicides, pesticides, agricultural water pollution, aquifer depletion, antibiotics in livestock, and accurate food labeling.

<u>Current Agriculture Finance</u> issues include consolidation in agriculture industries, crop subsidies, and the federal agricultural regulatory process.

Timeline for the Agricultural Study

January-February 2014: LWVUS announces consensus questions.

February 2014: Local Leagues study the issues, prepare presentations.

March 2014: Local Leagues present background information and consensus questions to their members for discussion and to reach consensus.

April 2014: Report consensus to LWVUS.

When we receive the consensus questions we will send them and background materials to all our members.

League's Effort Pays Off

Measure M, a \$30 million Berkeley bond measure, was passed in 2012 to improve streets and related watersheds in Berkeley. The discussion before it was put on the ballot was very polarized, so there were concerns about how to best implement the measure and if a consensus could be reached.

For nearly the entire past year, a public process was followed to determine how the money will be spent. It was led by the Berkeley Public Works Commission and cosponsored by the LWVBAE, with participation of the Community Environmental Advisory, Transportation and Parks and Waterfront Commissions. The outcome of the community dialogue was a process and criteria used to arrive at the next years' paving plans. The process and plan were passed by the City Council Nov. 19.

Members of the City Council were very complimentary of the process and the consensus reached with two Councilmembers singling out the LWVBAE for praise.

The League also recommended that the Board audit its administrative activities and review staffing levels, streamline processes, and improve efficiency in order to limit increases of the unit registration fee that supports its operations. We also recommended that the Executive Director's salary actions be reviewed by the Board based on annual performance reviews.

Sex Trafficking in Berkeley

Join us for February 18 Conversation

Although San Francisco and Oakland are considered by experts to be major sex trafficking hubs, it would be shortsighted to ignore the possibility of trafficking occurring in Berkeley. Many runaway and homeless teens are attracted to the area, providing a pool of vulnerable young people.

Last spring, the Berkeley City Council established a subcommittee, chaired by Vice Mayor Linda Maio, to address sex trafficking within Berkeley.

At our February 18 "Conversation", members of the subcommittee will tell us about the task with which they are charged, the goals they have adopted, and what progress has been made thus far.

The subcommittee is working with the Mills College Graduate Program in Public Policy to analyze the problem; a Mills graduate student is writing her master's policy report on the subject. Several policy options are being explored, including police training and protocol, anti-trafficking school curriculum adoption, data collection and victim identification, and creating a network with other cities and service providers in Alameda County.

Come join us at February's "Conversation" to hear subcommittee members discuss what they have discovered thus far, and to ask your questions about their research and possible recommendations they may make.

Join us Monday, January 13, 2014, 7:30-9:00p for Environmental Concerns with Aria Cahir of the Sierra Club speaking: "Is Hydraulic Fracturing of the Monterey Shale Formation Creating the New California Gold Rush?"

California sits atop a 1,700-square-mile oil shale deposit that might be accessed by hydraulic fracturing, also called fracking. Fracking is a largely unregulated process that forces large amounts of water, sand, and an undisclosed mixture of chemicals into the ground, in order to extract petroleum.

On the national level, fracking for oil and gas is still largely exempt from some environmental laws like the Clean Air and Clean Water acts, with protection of air and water quality only possible at the state and local levels. In California, by the industry's own estimate, more than 600 oil wells have been fracked in the last decade, with little oversight or monitoring.

The Monterey Shale formation stretches from northern San Joaquin into Los Angeles County. Nearly all oil already produced in California has come from the Monterey. It is not clear that fracking the Monterey is practical, but if so, fracked production from it could be very large indeed.

Our League Positions: The LWV at both US and California levels has a strong position for transparency, full disclosure and protection of public lands; management of public land needs to be done as a finite resource, not as a commodity, as part of that protection.

We support disclosure to the public of chemicals used in hydraulic fracturing, strengthening regulations related to well-bore integrity as well as disposal of waste water.

In October, 2013, the LWVC joined with more than 100 other groups to urge the Bureau of Land Management to cancel all oil and natural gas leasing on federal lands in California until a broad analysis of the environmental impacts of drilling and fracking is completed.

While working as a teacher and translator, Ann, along with the other knowledgeable Education Committee members, wrote deeply researched analytic reports about the BUSD budget and operations. Ann set and enforced very high standards for factual accuracy, clear thinking and succinct writing. In learning to meet those standards, many of us learned from her how to be effective League members.

Charlotte Lichterman: For years, she was our "women's issues" expert and an impassioned defender of abortion rights. An early adopter of email, she tracked and kept us up-to-date on these issues. She was proud to have become a 50-year League member. A couple of years ago, although she was not able to attend the Annual Luncheon, she nonetheless entered the raffle for the replica Susan B. Anthony purse; she won. When I took the purse to her at her apartment in Oakland we had a wonderful extended conversation.
